#### UPDATE: COUNTY LAW LIBRARY FUNDING & TASK FORCE

# **2007** *Public Funding Cuts:* As you may already know, January 1<sup>st</sup> marked the start of major public funding changes for the Cleveland Law Library. Pursuant to the



current biennial budget, Ohio counties will only be responsible this year for 80% of the "compensation" of their county law librarians. That means that Cuyahoga County will only have to pay 80% of the salaries (and possibly benefits) of our 3 county law librarians, and the Law Library will have to pay the remaining 20%. Thankfully, we are prepared to weather this new financial burden during 2007, and you should not see any significant changes to our collection. We also plan to continue to provide all of our regular services and increase our CLE offerings.

*Multi-Year Funding Cuts:* However, this year's 20% cuts are not the end of the story. Absent legislative changes, they represent only the 1st year of a multi-year statutory plan that will eventually shift 100% of these costs plus all Law Library expenses for rent and utilities *from* the County Commissioners *to* the Law Library Board by 2012.

*Task Force:* The ray of hope at the end of this tunnel is the Task Force on County Law Libraries that was created during Ohio's 2005 budget process. That Task Force is presently considering potential amendments to introduce in the upcoming budget process and will be issuing a formal report and recommendations by October 31, 2007. Our Law Library's Director has been a member of this Task Force since its inception and has been working hard to provide for the continued operation of a county law library system. #### ENHANCEMENTS TO WESTLAW STAFF PLAN: PUBLIC RECORDS, BRIEFS, REGULATIONS PLUS AND MORE!

In addition to recently adding many new *Westlaw* databases that you can now use at the Law Library, we also renegotiated our *Westlaw* staff plan for databases that our librarians and staff members can



search for you. We can retrieve items from these databases for free, and the only costs you will incur are for nominal printing and document delivery charges. We have many new additions to our staff plan, including:

**Public Records Databases:** The new Public Records databases include: people and business finders, criminal records, professional licenses, adverse filings, liens and judgments, lawsuit filings, *UCC* filings, business information, voter registration and political donor information. There are also asset databases that can help you locate information about real property, motor vehicles, airplanes and boats. A particularly useful feature is the ability to search a combined database of all available public records in a selected state. Of course, applicable law may require a permissible purpose for performing the public records search. The public records databases are part of a Bankruptcy Litigator package, which also includes bankruptcy treatises and news databases.

**Briefs:** Our new comprehensive Briefs database includes briefs from all fifty states and all federal courts. Previously, only the Ohio and U.S. Supreme Court briefs were in the library's "free" staff plan. Now, the library staff can search for a brief from a particular case or one that discusses a particular issue.

**Regulations Plus:** Another useful addition to the Library's staff plan is the Regulations Plus database. When we pull up a federal regulation in the *CFR*, we will also have access to annotations of cases dealing with the regulation. This database also provides links to prior versions of the regulation, links to statutory sources, and links to cases, administrative decisions, law reviews and secondary sources which cite the *CFR* section. The *Regulations Plus Index* allows you to search for *CFR* sections by topic.

**Verdicts and Jury Instructions:** We still have "free" access to the jury verdict databases, as well as model jury instructions for federal courts and all fifty states. Please take advantage of all these fantastic databases!
