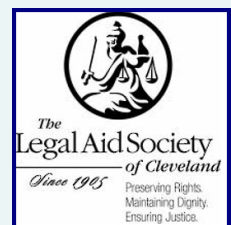
CLEVELAND LAW LIBRARY TO STAFF LEGAL AID BRIEF ADVICE CLINIC May 15, 2019

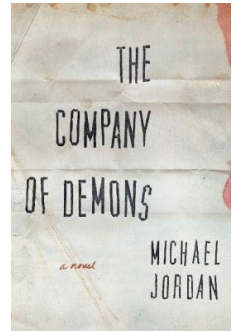

New Employee: Ashley Nix:

My name is Ashley K. Nix, and I would like to briefly introduce myself as the new Reference and Circulation Librarian at the Cleveland Law Library. I am an Ohio native, but still relatively new to the Cleveland area. I have always had a passion for librarianship, which I previously fueled by volunteering alongside the lead archivist at the Troy History Library in Southwest Ohio. I started my career as a paralegal in 2011 working for a high-volume personal injury firm and graduated in 2012 with my Associate of Applied Business in Paralegal Studies. Upon graduating, I attended Bluffton University, attaining my Bachelor of Arts in Organizational Management.



Following my graduation from Bluffton, I accepted a position with an insurance company's house counsel department, assisting senior and associate defense attorneys with motor vehicle and premises liability cases. Before long, I transitioned to another high-volume firm which allowed me the opportunity to work closely with two of their litigating partners.

In 2018 I was accepted to Kent State University's College of Communication & Information, where I am presently pursuing a Master of Library & Information Science. I began working as a Reference Librarian in a public library near Cleveland, with a goal of employment in a "special library" prior to graduation. Grant Funding:

The Law Library was recently awarded grant funding from the Ohio Consortium of County Law Library Resources Boards for a stand-alone kiosk with a touch screen, a two-way translation device, an *Oculus Go Virtual Reality Headset*, a table throw, and a retractable banner. This equipment will help the Cleveland Law Library stay on the cutting edge of technology, better serve its patrons, and market our services and resources to current patrons and potential new members.

New Virtual Displays:

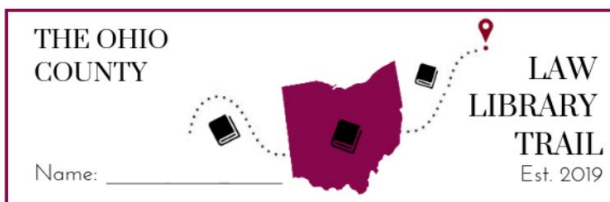

IS YOUR HOUSE YOUR CASTLE?

Ohio has a new self-defense law that became effective on March 28, 2019.* As part of its 132nd Session, the Ohio General Assembly passed [Am. Sub. H.B. 228](#), which changes the laws regarding both self-defense and handling firearms. According to the Ohio Legislative Service Commission, [H.B. 228](#) "[s]hifts to the state the burden to prove beyond a reasonable doubt that a person charged with an offense that involved the use of force against another did not use that force in self-defense, defense of another, or defense of that person's residence." Previously, that burden had resided with the individual asserting self-defense. The Ohio Judicial Conference is working on revised jury instructions to add to the criminal instructions in *Ohio Jury Instructions*.

*Certain provisions regarding preemption are not effective until December 29, 2019.



OHIO FAMILY TRUST COMPANY ACT

One of our patrons recently asked our Law Library staff to research [Ohio's Family Trust Company Act](#) contained in Ohio Revised Code Chapter 1112. This Act is still relatively new, having become effective just over 2 years ago on September 14, 2016. Under the law, a family trust company can be established as either a corporation or an LLC to serve family clients. It acts as a fiduciary, must be wholly owned by family clients, and must be exclusively controlled (either directly or indirectly) by one or more family members or family entities. In addition to other prohibitions, it cannot transact business with a person that is not a family client. A family trust company can choose to become licensed as a trust company in order to serve a slightly larger pool of family clients, but the statutes impose additional requirements regarding minimum capital, liability insurance, office space, and staffing. In addition, licensure comes with supervision and regular audits by the Ohio Division of Financial Institutions.



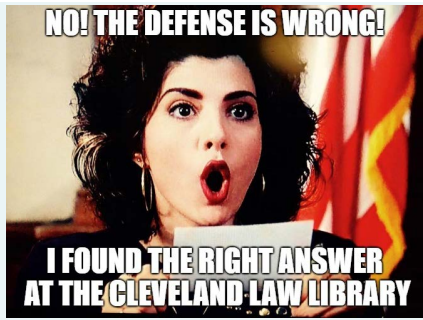
NEW 8TH DISTRICT WEB SITE
