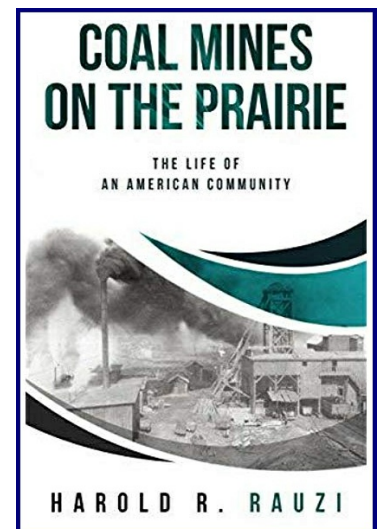

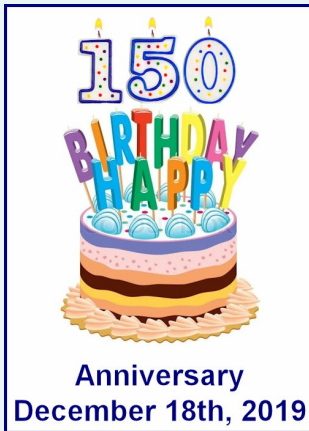
RANSOMWARE PROTECTION:

Are you protected from ransomware? There has been an increase in reported cases of this type of cyber attack recently. What is ransomware? Simply put, ransomware takes something of yours and demands payment for its return. This could be individual files on your computer or all of your files on your company's server. Protecting yourself from an attack should start with making sure your antivirus software is up to date. Most antivirus software has settings to download updates daily or even hourly. Make sure yours is set to automatically download the updates. You should also scan your system periodically to ensure you are not infected. It is not easy staying on top of all the newest threats, but dealing with an attack is much harder in the long run.

On-Demand CLE: The Law Library is very proud to announce that seven (7) of its legal research webinars are now available for purchase on-demand as self-study credit. This initiative was made possible through a brand, new partnership with the Cleveland Metropolitan Bar Association. The advertisement located at the top of this Newsletter provides a list of all available programs, and Law Library members who are interested in taking any of the classes should contact the Law Library for a discount code.

Technology Center: The Law Library recently created a new Technology Center in a historic room on the 4th floor that long-time members may remember using for legal research on CD-ROMs. The Technology Center will be used for hands-on technology training classes, live continuing education courses, video replays of previously-taped programs, book discussions on law-related topics, and joint programming with the Law Library's law-related partners. The Law Library unofficially opened the Technology Center with a soft launch during its September Open House, but a more formal opening is planned for the Law Library's 150th Anniversary on December 18th.

LSTA Grant: The Law Library recently obtained a Library Services and Technology Act (LSTA) grant from the State Library of Ohio. The Law Library will be using this grant to purchase technology tables for the Law Library's new Technology Center.

Consortium Technology Grant: The Law Library also obtained another grant from the Consortium of Ohio County Law Libraries. Among other items, this grant is being used to purchase three (3) very high-tech items. In addition to purchasing a hand-held two-way translation device and an Oculus Go virtual reality headset, the Law Library is in the final stages of acquiring a free-standing information kiosk for the Law Library's lobby.

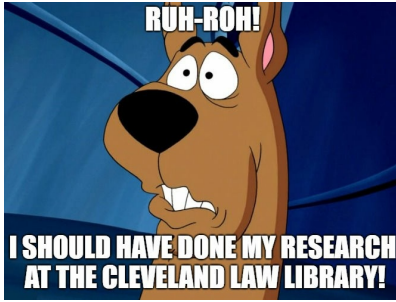

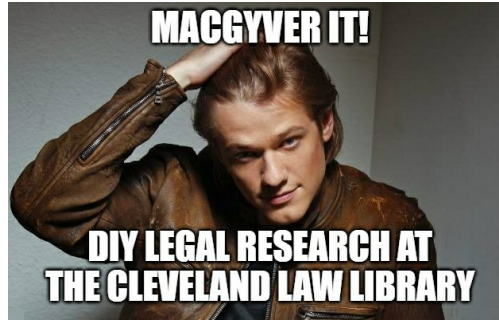
