TEMPORARY REMOTE ACCESS TO LEXIS AND WESTLAW CONTINUE FOR MEMBERS

The Law Library has been able to offer remote access to both *Lexis* and *West/aw* for many months during the pandemic. With health and safety conditions improving, the vendors may not continue their offers much longer. As a result, please take advantage of these benefits while they are still available.



LEXIS: LexisNexis is continuing to offer temporary remote patron access privileges to members of the LEXISNEXIS[®] Cleveland Law Library. If you have not already taken advantage of this opportunity, this option will allow you to log in from your home or office to use Lexis databases that the Cleveland Law Library is ordinarily only able to provide for members on-site at the Courthouse. Registration is required, but the process is pretty simple, and privileges will last for 30 days. Your 30 days of access all depends upon the date when you sign up. Members who wish to take advantage of this temporary benefit should follow these steps:
