- expanded our Internet FAQs; and
- provided increased Internet legal chat reference.

As part of my latest initiatives, we are putting in a wireless Internet LAN and updating our emergency plan.

### **NEW PATRON COPIERS**

If you didn't already notice on your last visit to the Law Library, we replaced our patron copiers and added the features you asked for. Two of the major enhancements include the ability to feed multiple pages at one time and make double-sided copies. These new copiers can also reduce and enlarge text and put two pages onto one. Just purchase a copy card at the front desk, and you are 'good to go.'

## PATRON CONFIDENTIALITY

Patron confidentiality is one of our primary administrative concerns here at the Law Library, and we are always looking for ways to further ensure your privacy. Our staff members have always protected patron contact information, circulation records, and reference and research requests from third party inquiries, and our external and internal electronic networks are also sufficiently protected from viruses and hackers. However, in an effort to enhance these safeguards, we purchased a shredder in the fall of 2004 to shred both request sheets and Interlibrary Loan sheets once the requests have been filled and necessary statistics have been collected. ## TECHNOLOGY'S EDGE: SCANNING AND PDF FILES

In an effort to enhance the services we provide to you and your attorneys, we have upgraded our staff copier/printer to a machine that prints in color and can scan documents into PDF format for attaching to an email. This means that if you are used to ordering a case, a law review article, a *Shepard's* printout, or another document by snailmail or fax, you now have the option to receive your order by email. We do not charge any retrieval fees, and the cost of transmittal is only \$4.00 per document. This feature holds wonderful promise for lawyers on the cutting edge of technology, and we hope that you will take full advantage of this new service.

## NEW SERVICE: LIBRARY STAFF CAN NOW PERFORM FREE WESTLAW SEARCHES

\* Regular document delivery charges still apply.

The library recently purchased an unlimited, fixed-rate subscription to *Westlaw's* "Gold Plan" for library staff use. This plan opens up many new avenues



of legal research for our members, the most important of which is the ability to search online in *West's* key number system. Our staff can now perform key number or digest searches for free. In addition, if you need to order a case by fax or email, you can now choose to have it sent from *Westlaw* so that it will contain *Westlaw* headnotes. If you desire, cases can alternatively be sent to you in "Reporter Image" format, which is an exact duplicate of the book version.

Our new plan provides access to all state and federal primary material (statutes, case law, codes, administrative decisions), as well as Ohio and federal analytical materials. The analytical materials include: *Ohio Jurisprudence with forms*, *Baldwin's Ohio Practice Library*, *American Jurisprudence 2d*, *Am.Jur. Proof of Facts*, *Am.Jur. Trials*, *Am.Jur. Pleading and Practice Forms*, *American Law Reports*, *West's Federal Procedure and Forms*, and *Wright and Miller Federal Practice and Procedure*. As a bonus, we also receive jury verdict and law review databases as part of our plan.

Additionally, the plan gives us access to materials that we did not have before in either print or electronic format. These include *Ohio Civil Rights Commission Decisions*, the *American Law Media Verdicts Database* and certain law review titles. We also acquired electronic searching capabilities for some items which we previously maintained only in print. Although the plan also includes *Keycite*, we have retained our free *Keycite* plan that members can use in the Library.
