**NOTICE
OF THE 2005 ANNUAL
MEMBERSHIP MEETING
APRIL 19, 2005**

The Annual Meeting of the members of the Cleveland Law Library Association will be held on Tuesday, April 19, 2005 at 12:00 p.m. in the Law Library, 404 Cuyahoga County Courthouse. Agenda items will include the election of three (3) trustees to serve three-year terms from April 2005-2008, the Librarian's Report, and a potential amendment to the Constitution to modify the Trustees' duties with regard to the approval and/or ratification of Law Library bills.

**HOUSE BILL 66
AND THE FUTURE
OF THE CLLA**

As you may already be aware, language in the Governor's current biennial budget bill (HB 66) will dramatically cut funding for Ohio's County Law Libraries, including the Cleveland Law Library (CLLA). Over the course of 5 years, beginning in 2006, HB 66 would rapidly eliminate County obligations to provide the CLLA with the salaries of our 3 County librarians, space, utilities, and furnishings. By the year 2010, these expenses would constitute 50% of the Law Library's budget. It is no exaggeration to say that the Law Library could not absorb such drastic cuts without significantly reducing the valuable legal services and materials we provide and upon which you have come to rely.

HB 66 is on the fast track and will be heard in the full House Finance and Appropriations Committee on March 15-17, 2005. The full House is expected to vote on April 13, 2005, and the Bill will probably be passed by the end of May. As a result, there is no time to lose.

Please help us by writing a letter to the following House representatives expressing your concern over the proposed changes to the funding for our law library. Enclosed with this Newsletter is a proposed letter containing suggested language that you are free to borrow.

In honor of this year's Law Day, we will again be sponsoring free *Lexis* CLE at the Law Library. If you missed our





Proposed Letter on behalf of the Cleveland Law Library:

As a constituent and member of the Cleveland Law Library, I would like to express my objection to proposed amendments in HB 66 that would abolish County funding for Ohio's 88 county law libraries. Based on the vital role county law libraries play in providing quality legal resources and services to Ohio's Judges, local, county and state officials, attorneys and members of the public, I urge you to remove this language from HB 66.

Suggested changes in lines 21548 to 21665 of HB 66 seek to amend O.R.C. §§ 3375.48-3375.55 to eliminate current County obligations to provide space, utilities, furnishings, and the salaries of a head librarian and two assistants for each of Ohio's county law libraries. Beginning in 2006, HB 66 would rapidly shift increasing percentages of these burdens to the Boards of Trustees of the County law libraries until 2010, when the county law libraries would have to pay 100% of their salaries and overhead from income they derive from state and municipal traffic fines.

Unfortunately, the county law libraries have already suffered dramatic reductions in these revenue streams. For example, in the last 10 years, the Cleveland Law Library, which serves as the Cuyahoga County law library, has seen an 87% drop in its state highway patrol funds. Local police have also been writing more and more tickets under local ordinances, thereby circumventing the statutory mechanisms under which the county law libraries would receive additional statutory funds. In addition, minimal antiquated statutory caps on certain funds county law libraries receive from municipalities, local courts, and the Ohio State Liquor Commission have never been amended to account for either time or inflation since 1953. In contrast, costs for essential print and electronic legal materials continue to escalate at the rate of 6-10% annually. As a result, county law libraries will be unable to absorb HB 66's accretions without depleting their collections and drastically reducing their services. In Cleveland's case, it will mean shaving one fifth off of its current budget. Smaller county law libraries will likely be hit even harder, and some may be forced to close completely.

While Ohio's county law libraries struggle to maintain and modernize library collections under these unfortunate circumstances, they nevertheless serve a diverse body of patrons, including court personnel, elected and appointed officials at the state and local levels, large and small law firms that are experiencing in-house budget reductions, solo practitioners who cannot afford to maintain their own legal libraries, and members of the public at large acting pro se. The legal system rests on access to reliable legal information provided by Ohio's county law libraries. However, the needs of these patrons cannot be served solely by use of the Internet.

For all of these reasons, I respectfully ask you to strike the provisions of HB 66 that would cut county law library funding and jeopardize the provision of legal services to the people and officials of Ohio.
