

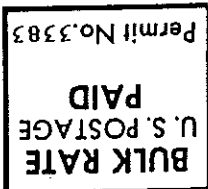
LIBRARIAN BARNER TO RETIRE

WESTLAW SEARCH TIPS

Following are some suggestions to make your Westlaw searching more cost effective, especially for the infrequent user.

1. Use Westlaw in the Law Library rather than as a private subscriber in your own office. Under the Library's subscription plan, searches cost either \$2.75 per minute for public terminal users or \$3.00 per minute for staff assisted searches. There is no charge for connect time. Under the private plan, you pay \$4.50 per minute plus a connect time charge.

2. Use the "DB" command to get out of billable time when you need to restructure your search, consult the directory for other data bases, or simply need time to think. There is no charge for time spent in the data base directory in the Law Library's subscription plan; in the private plan the connect time charge applies.

3. Use Westlaw to print full text of cases which are available only on-line. If the cases are available in print, take your citations from Westlaw and consult the full text in its paper format in the Library.

4. Once you have determined that a case is relevant, print it rather than read it on-line. There is no extra charge for printing and you will save money by reading the printout rather than trying to read and take notes on-line.

5. Use the search save capability when you need to interrupt a search session or if you just want to take a break. You can recall your search later in the day without the need to re-access the data base and rerun your query.

6. Take advantage of training opportunities. An on-line tutorial is available free in the Law Library. Members who sign West's public terminal user contract may have free training by a West representative at the training center.

ACQUISITIONS
