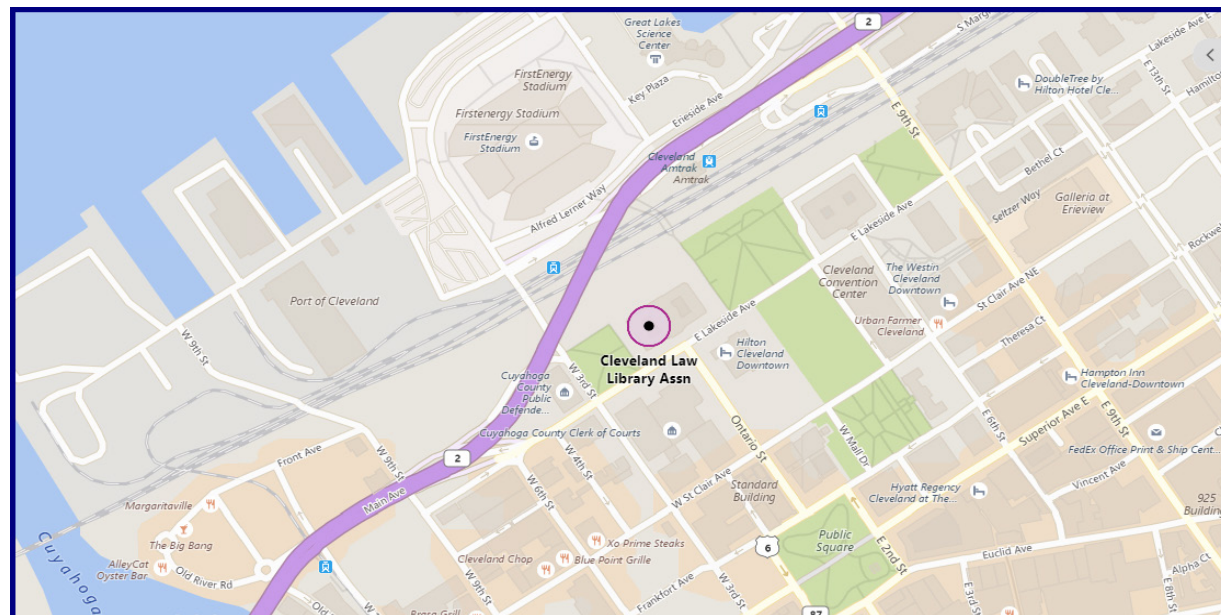

MISSION STATEMENT

The Cleveland Law Library's mission is to provide high quality legal research, education, reference and other related services to its various constituencies in an efficient and cost-effective manner utilizing its extensive collection in print and electronic format.

HISTORY AND STRUCTURE

The Cleveland Law Library was originally established in 1869 as the Cleveland Law Library Association ("CLLA") by leading members of the bar in Cuyahoga County for the promotion of the science of law. The CLLA is still one of the largest membership law libraries for practitioners in the United States, and it celebrated 150 years of service to the Greater Cleveland legal community in 2019. In 2009, legislation created a new entity called the Cuyahoga County Law Library Resources Board ("CLLRB"). The CLLRB provides services to local courts and governments as well as resources to serve the needs of self-represented litigants. These entities created a successful partnership that enables the Cleveland Law Library to remain an outstanding legal research institution on the cutting edge of technology.
